On-Site Laundry and You!

Your Management team is working hard to make sure you have access to the best possible laundry facilities. One of the new improvements you have likely already seen is "QR Codes" located in each laundry room. You can use these codes to report a laundry machine is out of order or another issue in a laundry room. Here is what happens when you leave a report.

1- Our office will receive your report immediately. Our maintenance team will investigate the machine at the next opportunity.

2– If our maintenance cannot resolve the issue, our Laundry Vendor, visits our machines once a week (Either Thursday or Friday.) Please note, many deficiencies require ordering parts that are suffering from supply chain shortages.

Remember, if you ever have a failed load, and you submit a report using the QR Code, our office will happily refund you the cost of your load of laundry. Just stop by our office to pick up your quarters.

July 4th Firework Safety!

The Fourth of July is almost here, which almost always means that fireworks are involved. Regardless of whether your community association already has rules or restrictions in place, here are 5 tips you can use to remind your residents about safety on Fourth of July, whether they celebrate in the community or not:

- 1. Use only legally purchased, approved fireworks. Use them as directed, under supervision and clear of any combustible material and clear of all buildings. Legal fireworks should be used or overseen by a responsible adult. No such fireworks may be thrown into, over, or around other homes, forested areas, or left in the common areas of the community.
- 2. Local Code enforcement Laws If you plan on using fireworks you should first check with the local law enforcement or city codes before setting off fireworks. There may be noise ordinances and fireworks may be illegal altogether. This goes beyond the governing by the community.
- **3.** Association Property rules and regulations If you plan on using fireworks for a 4th of July celebration, it is important to check your association documents, and association's CC&Rs regarding the use of fireworks.
- **4.** Safety-Insurance You need to fully understand your homeowners insurance policy regarding your own property damage, accidents or injuries as a result of using fireworks. If your fireworks go or land on another resident's property or on common areas, you may be responsible for damages to property and accidents or injuries that may occur.
- 5. Littering Fireworks leave debris, paper shreds, fuses, powder residue and other materials that may leave a mess and be potentially harmful. Be sure to clean up after your fireworks display.

To ensure a safe 4th of July, we encourage residents to know and adhere to all policies by your community association and local laws before having a fireworks display.
